### **OLD BUSINESS:**

- 1.** Comer Museum show is scheduled for June 2022 at this time.

- 6.** Concerning Board members: Board members agree that Web maintenance and Facebook maintenance are two separate positions. Both positions should have a voting member in each position. This leaves an even number of Board voting members. VOTE: To change by-laws via letter of update to separate Web maintenance and Facebook manentense into two Board positions.
